Director's Report: Area Managers' reports included in packet.

### Laura Leonard Reported:

- Circulation for 2020 was 962,806. Considering the closings and limited services for most of last year, this was not that bad compared to previous years. However, Summit County libraries have decided that circulation numbers will not be counted in the formula calculation for PLF funds for 2020 due to the circumstances.
- On December 28<sup>th</sup>, after the holiday weekend, we returned to very cold temperatures to the area covered by Air Handler Unit #1 due to a mechanical issue. The cost to repair the items needed and the boilers and pumps will be over \$20,000 and will need to be done in order to keep the building at appropriate temperatures.
- Emery Electric has completed the parking lot and outside building lighting. We will also be getting additional lighting for the flagpole and awaiting a quote on a new timer system for the parking lot lights.
- We will reopen to the public on January 18<sup>th</sup> with limited services. We hope to extend hours beginning February 1<sup>st</sup>, Monday thru Thursday 9:30am-8:00pm and Friday thru Saturday 10:00am-6:00pm.
- We still have three employees still on furlough.
- There will be a virtual Library Trustees Workshop on March 6<sup>th</sup> 8:45am-4:30pm. Please notify Laura Leonard if you would like to attend.
